Professor **Stanisława Golinowska** is one of the leading experts in social policy in Poland and a key contributor to the debates regarding transition reform in the fields of pension, health, social assistance and non-profit organizations.

Dr. Golinowska currently manages the Institute of Public Health at the Jagiellonian University in Cracow, where she also teaches the economics of health and social security. She is a founding member of CASE (Center for Social and Economic Research) and is the current vice-chairman of the CASE Council. Through CASE, she has coordinated several research projects in the area of social policy in the central and east European states.

From 1991 to 1997 she managed the Institut Pracy i Spraw Socjalnych (IPiSS) (Institute of Labor and Social Issues), Poland's central research institute in the areas of labor market and social affairs. At IPiSS she coordinated research projects in the areas of poverty and poverty-reduction, non-profit organizations, social insurance and the evaluation of social programs. She developed large scale comparative studies in the areas of social policy and the labor market and participated in several international research projects. As a member of the Rada Strategii Społeczno-Gospodarczej (Council of Economic and Social Strategy) from 1996, she advised the government of Poland.

Dr. Golinowska studied economics at Warsaw University, where she received her PhD (1978) and docent (1990) degrees in economics. In 1995 she became a full professor of economics. In 1988 and 1989 she studied German economics and social policy at the University of Mannheim on a grant from the German Humboldt Foundation and gained experience at the Center for Survey Research and Methodology (ZUMA), a German organization offering consultation services on the setting up, conducting and analyzing of social science studies for those working in social research.
